School Parents Teachers Association (PTA) and School Level Fee Committee (SLFC) for the session 2024-25 Dear Parents / Guardians,

The school is in the process of constituting the School Level Fee Committee (SLFC) with the parent representative whose ward/s is/are studying in the school in the current Session 2024-2025 and propose to study for the next academic session 2025-2026.

The school had already constituted the Parent Teacher Association (PTA) and now on formation of the PTA, a lottery shall be conducted (In case where application received are more than 5) by drawing a lot of the willing parents to constitute the School Level Fee Committee.

The Offline/Online procedures will be followed for the said committee.

All parent members of the PTA who are willing to become members of the School Level Fee Committee must satisfy the specified eligibility conditions mentioned below.

Eligibility / Conditions

1. Parents (PTA members) who give their consent through written application to be submitted to the School Office by hand along with receipt/screen shot of applicable fees as given in para 2 below on or before 06.05.2024 will be considered. The written application should reach the School Office before 5 P.M. on 06.05.2024.

2. As per PTA Act Fee of Rs.50/- is to be paid.

- 3. The applicant's ward should be a student of the school from Class Nursery to XII or at least is a student admitted from academic session 2024-2025 or propose to study for the next academic session 2025-
- 4. If more than one child is studying in the school, only one application per family will be considered.
- 5. Applicant should have sufficient knowledge about the functioning of the School System, Financial matters and the relevant guidelines of the Government on PTA/SLFC related issues.
- 6. The applicant should not be a Fee defaulter in paying fees of First Quarter session 2024-25 in our school records.

7. Ist Installment of School Fees of the session 2024-2025 should be cleared.

8. Applying in person should submit a printed/hand written application on 'A4' Size Sheet with all the supportive self-attested copies of the Documents: Aadhar, Last report card of ward, certificate of highest qualification of applicant.

9. In case there are excessive number of entries, the final selection would be done by lottery.
